

Village of Halsey Sales Tax Question

Shall the Village Board of Trustees of the Village of Halsey, Nebraska, impose a sales and use tax of one-half percent upon the same transactions within the Village of Halsey, Nebraska, on which the State of Nebraska is authorized to impose a tax?

"FOR" VOTE: If a majority of the votes cast upon such question shall be in favor of the one-half percent sales and use tax then such tax shall be imposed by the Village of Halsey, Nebraska on the same transactions within the Village of Halsey, Nebraska.

"AGAINST" VOTE: If a majority of the votes cast upon such question shall be opposed to the one-half percent sales and use tax upon the same transactions within the Village of Halsey, Nebraska, then such tax shall not be imposed within the Village of Halsey, Nebraska.

In addition to the above, there is one proposed constitutional amendment and two proposed initiatives', of which the title and text will be published by the Office of the Secretary of State, once a week for 3 weeks prior to the General Election.
