Notice is hereby given that on Tuesday, the 12th day of May, 2026, at the Thomas County Courthouse, 503 Main Street, Thedford, Nebraska, the precinct polling place in Thomas County, Nebraska, an election will be held. The polls will open at 8:00 a.m. and close at 8:00 p.m., Central time. Said election will be for nominating candidates to various offices. Some races will not appear on the Primary Election as the number of candidate filings does not exceed twice the number of vacancies; these candidates are declared nominated and will advance to the November 3rd, 2026 General Election. Some races may not appear on all ballots as the candidates are elected by specific subdivisions and districts.
