Regular Meeting
February 3, 2026

The Thomas County Board of Commissioners convened in open and public session at 8:30 a.m., in the Commissioners meeting room of the Thomas County Courthouse, Thedford, NE. Members present were Pam Moody, Charles Daly and Lewis Herbaugh. Also present were board secretary/County Clerk Lorissa Hartman, road personnel Keith Hartman and Doug Heavican, County Highway Superintendent John Copland, County Treasurer Andrea Thomas, County Sheriff Joseph Smith and County Attorney Kurt Arganbright.

Office reports:

Clerk presented the January fee report for the office.

Election dates: February 17th last day for incumbents to file and March 2nd the las day for non-incumbents to file for office.

Assessor presented the assessment actions for 2026.

Zoning discussion was held on updating regulations to include Data Centers, BESS, and Crypto.

Reminder given about grinding the tree stump in front of the library given, Commissioner Moody will contact Tyler Teahon.

Treasurer presented the delinquent property tax list to the board. These will be advertised in February 5th, 12th, and 19th in the Thomas County Herald. The Treasurer also reported on the changes to statute 77-1818, mainly the change in advertising fee and administration fee.

Sheriff reported on the upcoming changes to the Interlocal agreement for Region 26.

Region 26 also received congressional funding from Senator Deb Fischer in the amount of \$415,000.

The Sheriff will prepare LEOP training for the board and elected officials in the future.

He provided a safety committee report and an area activity report.

Motion made by Daly and second by Herbaugh to reappoint the following members to the Thomas County Planning Commission with a term expiring in 2028: Rahn Bek, Cay Ewoldt and Miles Maseberg. Roll call vote: Ayes – Daly, Moody, Herbaugh. Nays – none. Motion carried.

New Applied Connective quotes were reviewed for the road department shop security cameras. Motion made by Moody and second by Daly to accept Option 1 from Applied Connective to replace the existing security equipment at the road department shop. Roll call vote: Ayes – Herbaugh, Daly, Moody. Nays – none. Motion carried.

Lease agreement with Sock’s Garage for the propane tank was tabled. The County has not received back from the Title Company the signed document.

The easement with Flying A was discussed. After conversation with the County Attorney it was decided that the landowner or trustee needs to contact the County Attorney about proceeding with the easement. The County Clerk will notify Bob Broweleit with the Thomas County Visitors Committee.

No public comment.
